Approve Budget Calendar for 2021- Council was given a Budget Calendar for FY2021-22 for consideration. With this calendar, the Council will begin holding budget sessions in April, and the target date for budget approval is June 8, 2021. Also, Councilmember Coley asked if the entities being funded by the City could bring a bullet point summary of what they have done with the funds given by the City. Consider approval of a Resolution and Certified Assurances for the CHIP 2021 grant application. Council was asked to approve a Resolution and certified assurances documentation for the upcoming CHIP application. The CHIP grant application will be for \$400,000, and is due on Friday, January 29. Council was asked to approve resolution that will be included in this coming year CHIP application with certified assurances. The Mayor is authorized to sign the appropriate documents. Councilmember Lemmon made the motion to approve the resolution for the CHIP application with Councilmember Ates seconding the motion. Motion passed with all voting in favor. 5-0

Consider the DDA recommendation of appointing Mr. Vins Howell to the DDA to fill the unexpired term of Glenn Sawyer. DDA director, Rusty Lloyd gave a background on Mr. Howell. He is a business owner in the City and the DDA has approved his appointment. Councilmember Coley made the motion to approve Mr. Howell with Councilmember Ates seconding the motion. Motion passed with all voting in favor. 5-0

Consider an appointment to the Recreation Board recommendation to appoint Justin Frederick to serve as a City appointee on the Cochran/Bleckley County Recreation Board. Recreation Board sent a request to the Mayor for Mr. Frederick to be placed on the CBRD Board. Mayor called for a motion. Councilmember Lemmon made the motion to approve Mr. Justin Frederick to the Recreation Board with Councilmember Coley seconding the motion. Motion passed with all voting in favor. 5-0

Consider extending supplemental pay benefit for two pay periods. Council could extend to the \$125 from 16-30 of January or could go two pay periods at a time. Discussion was made about the stipulations of the hazard pay. Councilmember Coley made the motion made the motion to extend the supplemental pay to Police, Fire and Public Works and all part time employees working full time hours until February 13, 2021. Motion passes with all voting in favor. 5-0

Consider reappointment of Edgar Jarrett to the Housing Authority Board. Mayor Yeomans stated he received a call from Housing Authoring wanting to extend Edgar Jarrett appointment for 5 years. Councilmember Ates made the motion to approve Mr. Jarrett for an additional 5 years to the Housing Authority Board with Councilmember Coley seconding the motion. Motion passed with all voting in favor. 5-0
